Welcome to the Hemonitor mobile application web interface!

We take the protection of your personal data and privacy very seriously. Your personal data is collected, stored and processed by the company Roche Jordan, address Al-Swefieh 19, Mahmoud Almousa Ubaydat St. P.O. Box 294, 11118 Amman, Jordan ("**Roche**") in accordance with the 27 April 2016 European Parliament and European Council Regulation (EU) 2016/679 on the protection of natural persons in the processing of personal data and the free movement of such data, the repealed Directive 95/46/EC on recognition (GDPR), and other relevant legislation.

The Hemonitor mobile application ("Application") offered by us and the doctor/nurse web interface ("Interface") associated with it, at web address <http://app.hemonitor-jordan.com> can only work if we process your personal data listed below. The processing of your personal data is carried out on the basis of Article 6(1)(b) of the GDPR, in order to fulfill the contract concluded with you (Terms of Use of the Interface).

This Privacy Notice lets you know:

- .What type of data we process;
- i.How it's done, and;
- ii.What are your rights.

Basic information about the interface

By registering an account in the interface, you acknowledge that the following personal data processing conditions apply to you:

The interface processes the following personal data about you:

- First and last name;
- Contacts (phone, email address);
- Connection's date, time and duration;
- Individual actions with personal data (depending on your role - either doctor or nurse - and the corresponding rights in the Interface) - editing personal data, adding and deleting patient accounts, changing contacts, etc.,
- Password;
- The address of the hemophilia treatment center;
- User preferences.

Roche will not share your personal data with other Hoffmann - La Roche Ltd. companies belonging to the group. Your personal data is processed by Bicepsdigital s.r.o. as an authorized

personal data processor (reg. code: 05382190; address Římská 12, Praha 2 120 00, Czech Republic), who is the technical service provider for the hosting and operation of the Application and the Interface.

Your personal data and records are stored in the Interface only as long as you use it. Your personal data will be permanently deleted when you cancel your account.

Your rights

Based on the terms of the GDPR, you have the following rights:

- .Receive your personal data and information about processing it (GDPR Article 15);
- i.Request correction of your personal data if necessary (GDPR Article 16);
- ii.Request deletion of your personal data, if Roche no longer has the right to process them, according to GDPR Article 17;
- iii.Demand suspension of the processing of your personal data according to GDPR Article 18;
- iv.Receive your personal data in a structured, commonly used format in a machine-readable form, and transfer them to another personal data processor, according to GDPR Article 20;
- v.File a complaint with the supervisory authority (Data Protection Inspectorate (Andmekaitse Inspeksioon) - www.aki.ee) if you find your rights have been violated.
